ASU scholarships and grants

More than 84% of ASU undergraduates receive some form of aid. Financial aid includes Federal Pell Grants and scholarships. Regardless of your family income, we encourage all students to apply. You might be surprised at what you're eligible to receive.

MLFTC scholarships and grants

ASU offers academic and need-based scholarships. MLFTC also offers financial aid through its own scholarship portal which is available to all admitted students.

- The Arizona Teachers Academy (ATA) at ASU award. Recipients of the Arizona Teachers Academy at ASU award will have all tuition and fees covered while attending the highest-ranked college of education in Arizona.
- **TEACH grant**. The federal Teacher Education Assistance for College and Higher Education Grant can provide up to \$4,000 per year while you complete your degree.

Earn while at ASU

Several options are available for paid positions while you attend ASU.

- Federal work-study is a need-based program that encourages community service work related to your course of study.
- · ASU hourly employment is available throughout the year and new jobs are posted daily.
- Education at Work is a nonprofit organization that partners with local employers to fill customer service positions with ASU students.

Important dates

To receive the most financial aid possible, you'll need to stay on top your to-do list. Below are important dates to remember.

- FAFSA 2024–25 academic year opening in December 2023. A new, simplified Free Application for Federal Student Aid will be available for students and families beginning in December 2023. You can create your FSA ID now. You will need to create an FSA ID in order to electronically sign and submit your FAFSA. If you are a dependent, your parent will also need to create an FSA ID. **studentaid.gov**
- Oct. 15: Applications for MLFTC scholarships open for fall semester of the following year.
- **Jan. 15:** Early priority application date for consideration for need-based grants for fall and FAFSA filing priority deadline.
- April 15: Deadline for undergraduates to apply for MLFTC scholarships for following year.
- June 15: Deadline for graduates to apply for MLFTC scholarships for following year.

Submit the 2024–25 FAFSA

Visit **fafsa.gov** and submit your 2024–25 FAFSA to learn how much financial aid you are eligible to receive. Be sure to enter ASU's Federal School Code: **001081**.
